*The NAC Focus Areas for 2023 are taken from the 2022 NAC Survey. Our primary constituents, Sisters and Lay Partners-in-Mission participated. The issues recommended are: Human Trafficking, Immigration, Poverty/Economics, Family including Mental Health and Violence and U.S. policies that affect the Good Shepherd mission worldwide. These issues also address root causes. They include but are not limited to: Covid-19, environmental degradation, and racism. These areas will be noted at the end of the issue description. We also address significant current issues which indirectly impact the other focus areas.*

## **SIGN-ONS:**

### ***NAC FOCUS AREA: Human Trafficking***

#### **ISSUE: FORCED AND CHILD MARRIAGE, AND HUMAN TRAFFICKING, IN AFGHANISTAN**

Content: letter to Ambassador Cindy Dyer (Ambassador-at-Large, Office to Monitor and Combat Trafficking in Persons) calling for the immediate and urgent attention to a life-threatening and growing problem: forced and child marriage, and sexual slavery, in Afghanistan.

Taliban fighters visit homes, universities, and even orphanages in search of vulnerable families with girls and widows. Senior Taliban officials take extra wives as war prizes, and other loyalists are rewarded with young women who no longer can go to school or dream of economic independence. Feeling they have no escape; girls are committing suicide at alarming rates. One former medical student shared she was even prohibited from that, stating, “I don’t want to be taken away, I want to become a doctor in the future. If I commit suicide, they will destroy my family.”

The letter requests a meeting with Ambassador Dyer to explore pathways to safety and security and effective ways to combat human trafficking in Afghanistan.

#### **ISSUE: EXTENSION LETTER TO 30 DAYS COMMENT PERIOD ON ASYLUM BAN**

Content: The Biden administration published a Notice of Proposed Rule Making that recycles prior Trump-era bans on asylum. In addition to the significant alarm this rule raises on substance, it is really concerning that this rule *only offers 30 days* to comment on such sweeping changes to asylum processing. The letter addresses this concern and requests a 60-day response.

## **ISSUE: NO TO FAMILY DETENTION**

Content: The sign-on letter expresses grave concerns over reports that the Biden administration is considering reviving the practice of family detention. We ask President Biden follow through on his campaign promises to end family detention and pursue humane immigration policies.

## **ISSUE: IMMIGRATION APPLICATIONS FOR RECENT EARTHQUAKE VICTIMS IN TÜRKİYE AND SYRIA 1 SIGN ON TALLY MARCH 2023**

Content: Letter on behalf of hundreds of American citizens who have pending family-based petitions with the DHS's United States Citizenship and Immigration Services and immigrant visa applications with the Department of State for immediate and close relatives impacted by the recent earthquake in Türkiye and Syria. The earthquake that struck both countries last month has created a once-in-a-century humanitarian crisis, and we urge both your departments to work jointly to take immediate action to expedite the review of these applications and petitions.

## **ISSUE: FAMILY DETENTION**

Content: On March 07, 2023, the New York Times reported that the Biden Administration is planning to “turn to increasingly restrictive measures as his administration prepares for the end of Title 42” and is now considering bringing back detaining entire families in ICE detention centers as they seek asylum at the U.S./Mexico border. Detaining children and their parents is a cruel and unnecessary approach, especially after escaping precarious conditions often void of dignity. The letter urges the administration to not detain families who seek safety and security in the U.S.

## **ISSUE: MARYLAND ACCESS TO CARE ACT (SB365/HB588).**

Content: The bill as it stands now accomplishes the following: 1) immigrant families in Maryland Health Benefits Exchange are able to buy into the marketplace regardless of immigration status 2) requires MHBE to submit a federal waiver to expand this eligibility and 3) ensures there is a plan to allocate subsidies to immigrant families. That means we met the crossover deadline and now need to focus our efforts on the Senate and getting appropriate funding for the subsidies.

## *NAC FOCUS AREA: Poverty/Economics*

### **ISSUE: INCREASES IN LABOR-HHS-EDUCATION APPROPRIATIONS FOR FY 2024**

Content: Letter to lead appropriators in Congress seeks an adequate share of funding for Labor-Health and Human Services-Education appropriations in FY 2024. This is a critical decision period in which House and Senate appropriators and Congressional leadership must decide on funding for appropriations overall and how it will be divided among the 12 appropriations subcommittees. The Labor-HHS-Education subcommittee covers funding for health care, research, and public health protections, substance use and mental health disorder prevention and treatment, job training, protections for workers, child care, Head Start, and other children's services, assistance for seniors and people with disabilities, education from pre-k through college, help for immigrants, heating and cooling assistance, anti-poverty programs, and much more. Many of these programs have lost ground for years; the letter gives examples and calls for funding adequate to meet today's needs.

Content The sign-on letter calls for \$6.35 billion in WIC funding to cover WIC caseload, fund set-aside priorities for technology infrastructure and breastfeeding, sustain the fruit and vegetable bump through fiscal year 2024, and exclude riders that would disrupt implementation of the WIC food package rule.

## **ISSUE: MEDICAID UNWINDING**

Content: Letter to Secretary Becerra addressing the Medicaid unwinding, which threatens to cause the greatest loss of Medicaid coverage in American history, disproportionately harming people of color and children. The letter urges HHS to make the strongest possible use of the legal authority recently granted by Congress to prevent state Medicaid programs from needlessly terminating health care for millions of eligible people.

## **ISSUE: GUN VIOLENCE**

Content: Letter asks the Appropriations Committees to provide at least \$468 million for Community Violence Intervention (CVI) initiatives in your FY 2024 legislation, of which \$200 million would fund the Department of Justice's (DOJ's) Community Violence Intervention and Prevention Initiative (CVIPI) and \$268 million would fund the Centers for Disease Control and Prevention's (CDC's) Community and Youth Violence Prevention Program.

Gun violence rates continue to soar across the nation, with nearly 49,000 people dying from gunshot injuries in 2021, marking the highest single-year number of gun deaths to be recorded in our nation.

The COVID-19 pandemic has laid bare vulnerabilities in the world pandemic preparedness and response architecture. Time and again countries with greater control over vaccine manufacturing and supply used that power to prioritize securing vaccines for their residents, often building a vaccine surplus, **while billions of people in poorer countries went without. More than 13 billion COVID-19 vaccine doses have been administered globally, yet more than two-thirds of people in low-income countries have not received a single dose.** Vaccine inequity has cost millions of lives, damaged the global economy, and increased the risk of new variants.

## **ISSUE: GLOBAL CRISIS RELIEF WITH THE IMF**

Content: In October of last year, NAC joined nearly 150 civil society organizations from around the world called on the International Monetary Fund to release a new issuance of at least \$650 billion in Special Drawing Rights to provide cost-free, debt-free, condition-free crisis relief for developing nations.

In advance of the coming Spring IMF meetings, and in the face of a potential global recession, we're preparing to reiterate this demand — this time directing our call to President Biden.

The demands remain the same as the last letter with a slight difference. In this case, the letter as concise as possible, with a clear focus on the benefits to the United States.

Content: The letter addresses root causes of migration. It notes the administration's investment strategy in Central America and the related human rights, corruption and economic development concerns.

## **ISSUE: LAW ENFORCEMENT ACCOUNTABILITY DATABASE**

Content: On May 25th, Biden signed an Executive Order which mandates that, within 240 days of its signing, the Attorney General establishes a National Law Enforcement Accountability Database as "a centralized repository of official records documenting instances of law enforcement officer misconduct." It's now been 282 days, there is no public database, and the AG has not issued a statement about its status. The letter discusses the need for transparency.

## ISSUE: END SOLITARY CONFINEMENT ACT

Content: Congresswoman Cori Bush will be introducing a new piece of federal legislation, the End Solitary Confinement Act. Drawing from the best policy components from across the country regarding youth facilities, mental health facilities, and adult corrections facilities, this bill would: a) end solitary confinement in federal prisons, jails, and detention other than for up to at most four hours for emergency de-escalation; b) require all people in custody, including in alternative units, to otherwise have access to at least 14 hours of daily meaningful group out-of-cell time, including access to at least 7 hours of daily group programming; c) enhance due process protections, such as access to representation and use of neutral decision-makers; d) create oversight and enforcement mechanisms, including mandatory reporting, a private cause of action, oversight by an ombudsperson and community body, and greater media access; and e) incentivize states and localities to adopt similar bans on solitary confinement.

It references the need for integral human development to be one main approach and also names a **Fossil Fuel Non-Proliferation Treaty**. Both of these are linked directly to SDG 6 Clean Water and Sanitation for all and SDG 7 access to affordable, reliable, sustainable, and modern energy for all.

The statement will be distributed among all UN National Delegates at the UN headquarters in NYC. At the invitation of the Laudato Si Movement, we signed on to the statement and shared it with others. Sr. Winifred signed on for the Congregation, Fran Eskin-Royer signed on for NAC.
